	Washington State Ferries is embarking on a \$50 million effort to convert its largest and dirtiest ferries to battery electric hybrids. This program will significantly reduce diesel and carbon emissions, improve reliability, save up to \$14 million on ferry operating costs and virtually eliminate engine noise that can hurt orca whales. We'll begin with an overview of the project and a hands-on tour of one of the ferries slated for conversion. On the ride back, we'll discuss opportunities to partner and collaborate.

	Washington State leads the US Climate Alliance , a coalition of 15 states and territories committed to meeting the Paris Climate goals. From climate policies like a proposed Carbon Tax , to clean energy like solar and hydro , and clean transportation initiatives like electric vehicles , electric ferries and ultra high speed rail , Washington state is at the forefront of American efforts to combat and defeat climate change.

12:30 p.m.	GREEN SHIPPING: MARITIME SUSTAINABILITY STRATEGIES
	Ocean health and new technologies will play major roles in the future of the maritime industry, and state leaders want Washington's \$37.8 billion maritime sector and its nearly 70,000 employees to help lead the way. In December, Governor Inslee launched the Washington Maritime Blue 2050 initiative, the first initiative of its kind in the US to bolster innovations in the maritime sector that create living-wage jobs, protect the environment and ensure sustainability for the industry. The initiative envisions ships and passenger ferries powered by electricity, zero-carbon-emission port terminals, more investments in research and development, and increased workforce training.
	Norway has launched several electric ferries, and hydrogen vessels are under development. The government strategy for Green Competitiveness identifies green shipping as an area of priority. The maritime industry, with political support, is now implementing its roadmap for green shipping, towards a low emission future . Lessons learned and shared perspectives on climate change between Norway and Washington provide opportunities for closer collaboration.
